

RESOLUTION NO. 2016-05

A RESOLUTION ADOPTED BY THE CITY COUNCIL OF THE CITY OF GREENACRES, FLORIDA, APPOINTING ANDREA MONZON MCCUE AS CITY MANAGER PURSUANT TO ARTICLE VIII, SECTION 2, OF THE CHARTER OF THE CITY OF GREENACRES, SUBJECT TO THE TERMS AND CONDITIONS SET FORTH IN THE ATTACHED EMPLOYMENT AGREEMENT.

WHEREAS, the City Council of the City of Greenacres is an elected, legislative and deliberative public body, serving the citizens of the City; and

WHEREAS, Article VIII, Section 2, of the City's Charter provides that the City Council shall appoint a qualified individual to serve as the chief executive and administrative officer, holding the title of City Manager; and

WHEREAS, the Council has advertised the City Manager vacancy and, upon receipt and review of numerous applications, identified Andrea Monzon McCue as the individual the Council desires to serve in the capacity of City Manager; and

WHEREAS, the City has conducted a background investigation and other pre-employment screening and finds Ms. McCue to be a qualified candidate for the position; and

WHEREAS, Ms. McCue will serve at the pleasure of the City Council, subject to the terms and conditions set forth in the negotiated employment agreement which is attached hereto; and

WHEREAS, the Mayor is authorized to execute the attached employment agreement on behalf of the City Council.

NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GREENACRES, FLORIDA AS FOLLOWS:

Section 1. Adoption of "Whereas" Clauses. The foregoing "Whereas" clauses are hereby adopted and incorporated herein.

Section 2. Appointment. The Council finds that Andrea Monzon McCue has the appropriate executive and administrative qualifications to serve as City Manager, therefore, she is hereby appointed as City Manager with a starting date of February 8, 2016, and shall serve at the pleasure of the Council, subject to the terms and conditions set forth in the attached employment agreement.

Section 3. Effective Date. This Resolution shall take effect immediately upon its adoption by the City Council of the City of Greenacres.
