

**AMENDMENT 001 TO THE AGREEMENT
WITH
CITY OF GREENACRES**

Amendment 001 entered into on _____, by and between **Palm Beach County** and the **City of Greenacres**.

WITNESSETH:

WHEREAS, Palm Beach County entered into an Agreement (R2016-0188) with the City of Greenacres on February 9, 2016 to provide \$125,767 in Community Development Block Grant (CDBG) funds for storm water drainage improvements along the alleyways between Fleming, Jennings, Perry and Martin Avenues and Swain Boulevard; and

WHEREAS, both parties desire to modify the original Agreement to provide additional funding for the project, and

WHEREAS, both parties desire to modify the original Agreement in accordance with the terms and conditions set forth herein; and

NOW, THEREFORE, in consideration of the mutual covenants and agreements hereinafter set forth, and various other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

- A. **INCORPORATION OF RECITALS**
The foregoing recitals are true and correct and incorporated herein by reference. Terms not defined herein shall have the same meaning as ascribed to them in the Agreement.
- B. **SECTION 5 - MAXIMUM COMPENSATION**
Replace "\$125,767" with "\$134,437".
- C. **EXHIBIT A – WORK PROGRAM NARRATIVE: SECTION 2. A: COUNTY OBLIGATIONS**
Replace "\$125,767" with "\$134,437".

Except as modified by this Amendment 001, the Agreement remains unmodified and in full force and effect in accordance with the terms thereof. This Amendment 001 is expressly contingent upon the approval of the County and shall become effective only when signed by all parties.
