**A RESOLUTION ADOPTED BY THE CITY COUNCIL OF THE CITY OF GREENACRES, FLORIDA, APPROVING THE APPLICATION FOR A SPECIAL EXCEPTION TO ALLOW AN INDOOR RECREATIONAL AMUSEMENT (GET HOOKED ARCADE) IN A COMMERCIAL INTENSIVE (CI) ZONING DISTRICT, LOCATED AT 3769 SOUTH MILITARY TRAIL, AS REQUESTED BY THE PETITIONER, KENNETH WOO, AGENT FOR THE OWNER, 3757 MILITARY TRAIL, LLC; PROVIDING FOR REPEAL OF CONFLICTING RESOLUTIONS; AND PROVIDING FOR AN EFFECTIVE DATE.**

*The petitioner is requesting Special Exception approval to allow for an Indoor Recreational Amusement facility in a Commercial Intensive (CI) zoning district.*

*On the southwest corner of South Military Trail and Bowman Street at 3769 S. Military Trail.*


**INFORMATION AVAILABLE TO THE PUBLIC:**


respect to the requested Special Exception approval. Additional information may be obtained by contacting the Planning and Engineering Department at (561) 642-2054.
